Overview

Increasing regulatory pressure to transition from conventional paper-based bill and payment processing to standardized electronic transactions is spurring leading insurers and third party administrators (TPAs) to evaluate technology solutions that provide compliance and improve operational efficiencies. In an effort to meet emerging regulatory requirements and increase overall the effectiveness and accuracy of claims and medical bill reporting, the workers' compensation industry is transitioning to Electronic Data Exchange (EDI). WorkComp.NET is a web-based application service provider (ASP) solution that eliminates the need to install and maintain desktop software and hardware and can support an unlimited number of users. All transactions occur over secure state-of-the-art Internet encrypted file transfer protocol (FTP) technology.

Security

All transactions are authenticated and encrypted using 128-bit secure socket layer (SSL) technology and digital certificates. Data is protected on privately enclosed servers housed in a high-security facility and requires password user verification.

Eliminate manual data entry by importing FROI/SROI from your claims management system via the Internet. If necessary, you can also supplement any additional information via data entry. You can import and process the International Association of Industrial Accident Boards and Commissions (IAIABC) Release 1, 2, and 3 formats or use generic XML for claims reporting for all claims regardless of state reporting requirements. Delivery-only services are also available to meet your claims reporting needs.

Medical Reporting Options

Our robust medical functionality allows payer-to-state medical bill processing using the Florida proprietary flat file, as well as IAIABC ANSI X 12 837 in Texas and California. The tool supports ASP model partial or full integration in addition to 997 (functional acknowledgment processing) receipt and creation. You can

easily import the Ingenix proprietary medical bill format to existing applications to create a single format that includes all data requirements for supported states. In addition, an easy-to-use graphic interface displays mandatory, conditional, and optional edits and allows users to view acknowledgment information for correction via WorkComp.NET.
